

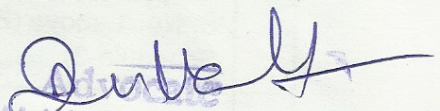

6. That the statement in the foregoing paragraphs(1) to (5) are true to the best of my knowledge and belief that nothing is false and nothing material has been concealed.

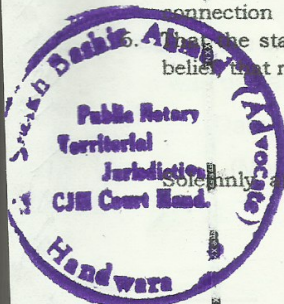
