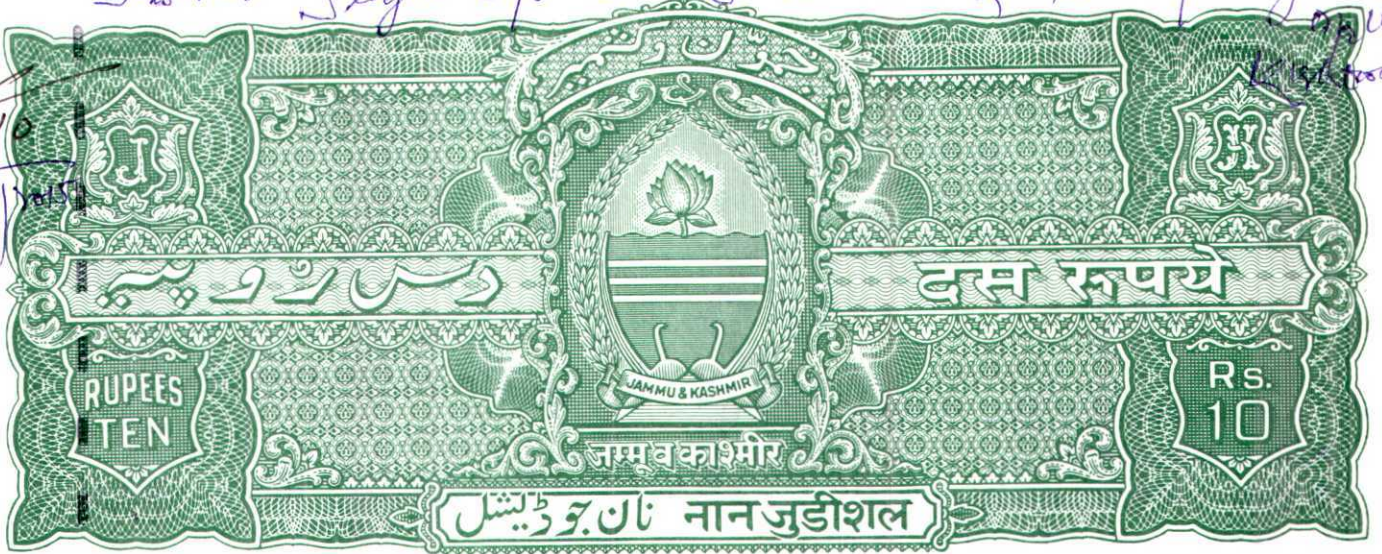

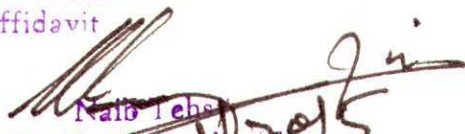
1. That I was contesting candidate at the general election/by election to the Legislative Assembly of J&K on 23.11.2014.

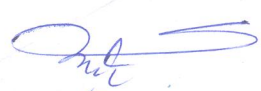
