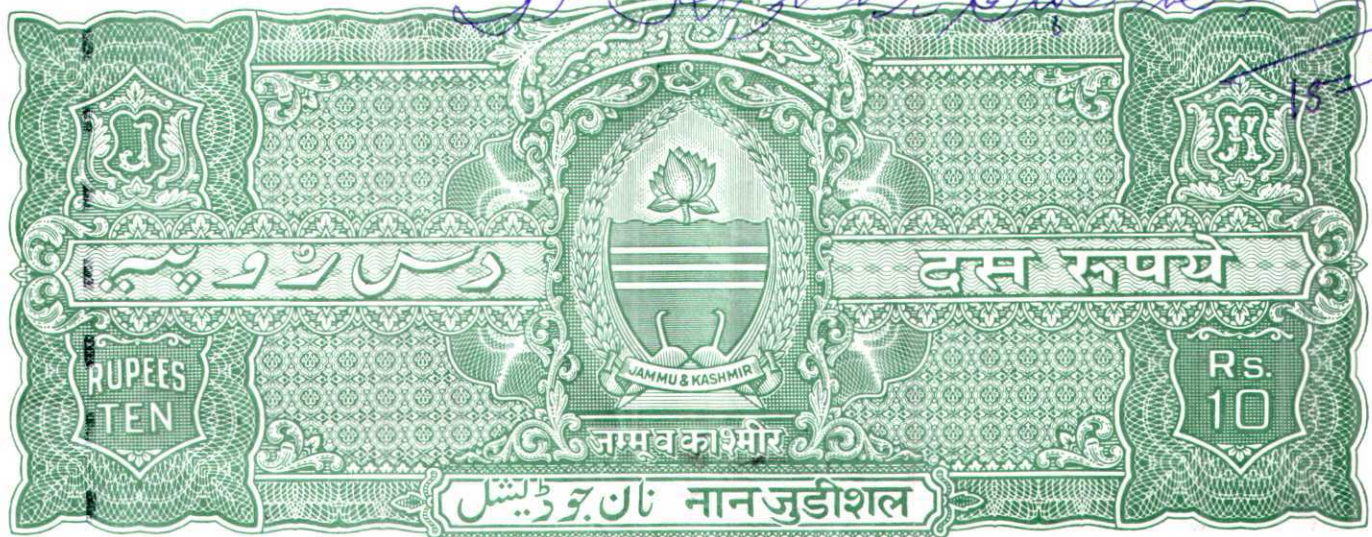




AFFIDAVIT
