As recommended by the Chairman District Level Selection Committee Pulwama District Election Officer (Dy.Commissioner) Pulwama, sanction is hereby accorded to the temporary appointment of the following persons as orderly on Class-IV posts in the Pay Scale Rs.4400-7440+ Grade Pay 1300/- in the J&K Election Department with immediate effect:-

2. The appointee shall report to the District Election Officer, Pulwama for duty. In case any appointee fails to join within the stipulated period of 21 days, his appointment shall be cancelled without any further notice.

3. They shall be allowed to join only on production of the following certificates/documents in original which shall be verified subsequently from the concerned quarters:-

1. Academic qualification certificates.
 2. Date of Birth Certificate.
 3. Health Certificate, issued by the Competent Authority.
 4. Permanent Resident Certificate.
 5. Relevant Category certificate (in case appointee belongs to Reserved Category).
 6. Certificate from General Manager, District Industries Centre concerned and Deputy Director Employment concerned to the effect that no loan is outstanding against the appointee under any scheme.
4. The appointment of the above as orderly shall further be subject to the following conditions:-

- a) The appointee shall give an undertaking, duly attested by Judicial Magistrate, to the effect that in case adverse report about his Character and Antecedents is received from the CID, J&K to whom a reference shall be made by the department, the appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.
- b) The verification report of Qualification Certificate/Reserved Category Certificate (wherever necessary) from the concerned quarters/issuing authority and if any of these are found to be invalid, fake or incorrect, the appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.

The salary of the appointee shall not be drawn and disbursed unless satisfactory report in respect of (a) and (b) above is received. The appointment of the above shall be governed by the "New Pension Scheme" and SRO. 202 of 2015 dated 30-06-2015.

5. The appointee shall be on probation for a period of five years.
6. The inter-se-seniority shall be in the order in which the appointee appears herein above.
