Sir/Madam,

The Panchayat Electoral Rolls in Hindi and Urdu are supplied to DPEOs / DCs of the concerned districts. In this context, I am directed to invite your kind attention to verify the fact of availability of Panchayat Electoral Rolls (Mother Rolls and Supplements) in required numbers for the District. Further refer to instructions issued by this office for preparation of Panchayat Electoral Rolls vide this office No: 105/PE/ER/2010/1611-40 dated 22-02-2011 wherein you were requested to constitute teams of officers/officials for the preparation of the marked copies of computerized Electoral Rolls as printing of Mother Roll (Draft Roll) and supplements for addition, deletion and modification has been made separately due to paucity of time.

The detailed schedule for the conduct of Panchayat Elections has been announced by the competent authority. So, keeping in view, the phases notified in the schedule, you are requested to kindly ensure that marked copies of all the blocks are prepared well in time. The DPEO's / DC,s Kupwara, Baramulla, Ganderbal, Anantnag, Kulgam, Budgam, Jammu, Samba, Udhampur, Kathua and Reasi where elections are scheduled to be held in initial phases, shall complete the marking exercise by or before 31.03.2011 especially for the Blocks where elections are to be held in first, second and third phase. The remaining blocks/

districts will complete the preparation of marked copies as per instructions issued by this office by or before 10.04.2011. A certificate in the format given below may be furnished to this office after the completion of the marking exercise:-
